Proposal Package Name	Proposal Package Description
Proposal Package 16A - HVAC - Air - East	The scope of this package includes air distribution systems and equipment on the east side of the stadium within zones B2, B3, C1, C2 and part of D1 between column lines CL 11 clockwise to CL 34 on Field Level and Mezzanine Level and CL 11 clockwise to CL 35 on remaining levels. Work includes all supply, return, exhaust duct work, boiler flues, accessories, air handling units, fans, energy recovery ventilation units, DOAS units, Package RTUs, VAV boxes, split AC units, VRF systems, and infrared radiant heaters.
Proposal Package 16B - HVAC - Auxiliary Building CRAC Units	The scope of this package includes all HVAC systems and equipment for the Technology Building, ECC Pump House and Bills Pump House. Work includes computer room air conditioning (CRAC) units with remote air cooled condensing units, refrigerant piping, packaged heat pump RTUs, supply, return, outside and exhaust ductwork, exhaust fans, electric terminal heaters, and electric terminal heaters.
Proposal Package 16C - HVAC - Air - West	The scope of this package includes air distribution systems and equipment on the west side of the stadium within zones B1, A2, A1, D3, D2 and part of D1 between column lines CL 11 counter clockwise to CL 34 on Field Level and Mezzanine Level and CL 11 counter clockwise to CL 35 on remaining levels. Work includes all supply, return, exhaust duct work, boiler flues, accessories, air handling units, fans, smoke control systems, energy recovery ventilation units, DOAS units, Package RTUs, pool dehumidifier, VAV boxes, split AC units, VRF systems, and infrared radiant heaters.
Proposal Package 16D - HVAC - Wet	The scope of this package includes all hydronic system piping, pumping, equipment and accessories including heating hot water/glycol boilers, heating terminal units, A/C water/glycol chillers, condenser water cooling towers, roof snow melt boilers and tubing, field level snow melt heat exchangers and tubing, field root zone heat exchanger and piping (excluding field tubing). Excludes Auxiliary building, concessions, and suites.
Proposal Package 17A - Electrical High Voltage Distribution	Installation of High Voltage Pre Purchased Equipment including Utility Switchgear, Metering/PT/CT Cabinet, MV Transformers, and Main Service Substations. Provide all high voltage distribution feeders and raceway. Provide all power and lighting for Auxiliary and Electric Service Buildings including install of UPS in Auxiliary Building.
Proposal Package 17B - Electrical Emergency Power (EPS)	Provide all Emergency power equipment including Generators, Paralleling Gear and ATS. Provide all emergency power feeders and raceway from generators to ATSs and from ATS to MSAs.

Proposal Package 17C - Electrical Branch	Provide all remaining switchgear, panels and transformers. Provide all distribution feeders and raceway from MSAs to 480V (and below) switchgear, panels and transformers. Provide all power and lighting for levels below Level 200.
Proposal Package 17E - Electrical Branch (Level 200 and above)	Provide all Power and Lighting for Level 200 and above. Provide all stadium lighting.
Proposal Package 18A - Underground and Storm System Plumbing	Provide all underground and storm system plumbing for the stadium.
Proposal Package 18B - Plumbing Auxiliary Building	Provide all plumbing for Auxiliary and Electric Service Buildings.
Proposal Package 18C- Plumbing Stadium	Provide all above ground sanitary, domestic water, and natural gas systems for the stadium. Provide all food service connections. Exclude storm.
Proposal Package 19A - Fire Protection	Provide all fire protection systems and equipment for stadium.
Proposal Package 19B - Fire Protection - Auxiliary Building	Provide all fire protection systems and equipment for Auxiliary Building and Electric Service Building.
Proposal Package 21 - BMS/Controls with Fire Alarm	Provide all Fire Alarm, Smoke Management, Control and Building Management Systems
Proposal Package 23 - Audio, Distributed TV & Broadcast Systems	Provide all AV, IPTV, 2-way Emergency Communications, Emergency Responder, and Broadcast Cabling Systems. Provide all TV mounting hardware and install TVs.
Proposal Package 24 - Security and Telecomm	Provide all Structured Cabling, Converged Network, High-Density Wi-Fi, Electronic Security, Access Control and Video Surveillance systems.
Proposal Package 56 – Pools, Saunas and Steam Rooms	Provide all pools, saunas, steam, and similar therapy equipment.
