Proposal Package 25a – Drywall - Field, Mezz., Main	Scope of Work includes, but is not limited to: layout, framing, insulation, sheathing, wall board, finishing (i.e. taping, trim, finishing, and sanding), shaft wall assemblies, ceiling / ceiling finishes, wall finishes (e.g. acoustic wall and FRP paneling), and blocking (for Others). Work is limited to the following levels / area: Field , Mezzanine, and Main Concourse. Work on the following levels shall be performed by Others: [1] Lower Suite and Club, Upper Suite and Club, West Club, Upper Concourse, and Press; and [2] the Auxiliary (Aux) Building.
Proposal Package 25c – Drywall - Suites, Club, Upper, Press	Scope of Work includes, but is not limited to: layout, framing, insulation, sheathing, wall board, finishing (i.e. taping, trim, finishing, and sanding), shaft wall assemblies, ceiling / ceiling finishes, wall finishes (e.g. acoustic wall and FRP paneling), and blocking (for Others). Work is limited to the following levels / area: Lower Suite and Club, Upper Suite and Club, West Club, Upper Concourse, and Press. Work on the following levels shall be performed by Others: [1] Field, Mezzanine, and Main Concourse; and [2] the Auxiliary (Aux) Building.
Proposal Package 26 – Stadium Seating	Scope of Work includes, but is not limited to: furnish and installation of all stadium seating (e.g. seats, backs, fixed, padded upholstered, reclining, wheelchair companion stadium chairs, and portable seating platforms), seating components (e.g. frames, riser mounted stanchions, and horizontal mounting beams), and seating accessories (e.g. cupholders, armrests, tablet arms, and identification plates).
Proposal Package 27 – SOFP & Intumescent Paint	Scope of Work includes, but is not limited to: sprayed fire-resistive materials (Spray-on Fireproofing) and intumescent fire-resistive coatings (Intumescent Paint) on interior surfaces concealed from view and exterior exposed surfaces. Intumescent paint shall be limited to work onsite that was not prefinished by Others.
Proposal Package 29A – Misc. Metals - Bowl Railings	Scope of Work includes, but is not limited to: pipe and tube stair railings attached to precast / wall, seating bowl rail system, drink rail, cable rail, galvanized guard rail, suite separation rail, courtesy rail, glass rail, railing components (e.g. base plates, brackets, sleeves / inserts, and posts), bar gratings, camera platform railings, and railing accessories (e.g. rail mounted cupholders, counter supports, protection caps, etc.).
Proposal Package 29B - Misc. Metals - Masonry / Hoistways	Scope of Work includes, but is not limited to: furnish and installation of miscellaneous metals integral to the masonry, elevator, and escalators (i.e. 'back-of-house'). Components include: hoist beams, divider beams, lintels, framed openings, sill supports, angles, and support steel.

Work is limited to the following levels: Main Concourse, Lower Suite and Club, Upper Suite and Club, West Club, Upper Concourse, and Press. <p>Proposal Package 59 - Playing Field</p>	<p>Scope of Work includes, but is not limited to: natural turf, synthetic turf and accessories (e.g. attachment curb, warning track, access covers), irrigation system, hydronic heating / snow melt piping, and goal posts with associated foundations. Coordination required with the Vendor furnishing the equipment and controls for the Playing Field Heating & Aeration System.</p>
