BID PACKAGE 08C – Foundations	The scope of this package includes all cast-in-place concrete for footings, pits, grade beams, plinths, vaults, walls retaining earthwork (excludes east / west side H-pile, shotcrete, tie-back walls), slab-on-grade, foundation uplift anchors, and temporary foundation concrete / piles for hoists for the stadium.					
BID PACKAGE 08D – Foundations Aux Building	The scope of this package includes all cast-in-place concrete for footings, pits, grade beams, plinths, and slab-on-grade for Auxiliary Building.					
BID PACKAGE 10A – Structural Steel & Canopy Roof	The scope of this package includes furnish and installation of all structural steel, MEP dunnage, metal decking, shear studs, and canopy catwalk systems at the stadium. Shop installed coatings of exposed to view structural steel. Installation only of structural precast foundation walls and seating bowl scope furnished by others. Provide crane picks for other trades as defined by GT.					
BID PACKAGE 10B – Structural Steel – Aux Building	The scope of this package includes furnish and installation of all structural steel, MEP dunnage, metal decking, and shear studs at the Auxiliary Building. Provide crane picks for other trades as defined by GT.					
BID PACKAGE 15 – Structural Precast/Stadia (Furnish Only)	The scope of this package is to furnish ONLY (installation by structural steel) all structural precast foundation walls, seating bowl walls, stairs, stadia seating bleachers, seating tubes, and associated connection hardware. Engineering is delegated design and the responsibility of the trade partner.					
BID PACKAGE 11A – Exterior Glass & Glazing (Entrances)	The scope of this package includes furnish and installation of all exterior aluminum framed entrances / storefronts (GL1T, GL4T), exterior aluminum / glass doors (GL1T, GL4T), associated door hardware (GL1T), glazed aluminum curtain wall systems (GL1, GL4, GL4), & GL6), aluminum windows, and louvers within exterior wall systems enclosing the building. Engineering is delegated design and the responsibility of the trade partner. Provide all firestopping and waterproofing tie-ins at exterior walls.					
BID PACKAGE 11B – Perforated Metal Panel System & Colonnade Wrap	The scope of this package includes furnish and installation of all exterior façade perforated metal panels (MP1) (above the thin brick precast façade) and perimeter colonnade wraps (MP4) at each radial grid line. Engineering is delegated design and the responsibility of the trade partner.					
BID PACKAGE 11C – Thin Brick Exterior System	The scope of this package includes furnish and installation of all exterior façade architectural precast with thin brick (BRK1) and other exterior precast façade (PC1) elements. Engineering is delegated design and the responsibility of the trade partner.					
BID PACKAGE 11D – Metal Panels	The scope of this package includes furnish and installation metal panel system at top of exterior wall at edge of canopy (MP6). Engineering is delegated design and the responsibility of the trade partner.					
BID PACKAGE 12 – New Stadium Site Utilities (Excluding Smoke Creek Line)	The scope of this package is to furnish and install water, sanitary, and storm systems outside of the stadium. Excluded from this package is any water, sanitary, and storm work included in BP#03a and BP#03b bid packages. Also, excluded is site underground electrical work.					
BID PACKAGE 13 – Concrete on Metal Deck	The scope of this package is to furnish and install all superstructure fill-on-metal deck / cast-in-place concrete, topping slabs, stair pan fills, curbs, stadia aisle site cast steps, stadia overbuild platform slabs, and grouting of structural steel column base plates.
