PROPOSAL PACKAGE NAME	PROPOSAL PACKAGE DESCRIPTION
28A - Roofing	Scope of Work includes, but is not limited to: roofing (e.g. flat, tapered, metal subroof, standing seam, elastomeric, and thermoplastic polyolefin), polyisocyanurate insulation, cover board, sheathing, membrane, flashings, primer, underlayment / cover and substrate boards, sheet flashings, through-wall flashings, counterflashing, extrusions, penetration boots, brake metal, terminations, battens, fasteners, adhesives, caulk / sealants, associated rough carpentry, expansion joints, gutters and downspouts, blocking, treated wood, roofing specialties (e.g. copings, roof-edge fascia, roof-edge drainage systems, scuppers, etc.), roofing accessories (e.g. roof hatch, safety railing system, walk pads, etc.), and snow guards.
28B - Waterproofing	Scope of Work includes, but is not limited to: above-grade waterproofing, fluid-applied air barrier, backer rod, closure strips, cover trim / flashings, and molded drainage panels. Locations throughout stadium and includes split slab transitions, escalator pits, trench and drains. Waterproofing within any brick / CMU cavity walls, at tile backer board, and below grade shall be performed by Others.
29E - Overhead Coiling Doors	Scope of Work includes, but is not limited to: furnish and installation of all overhead coiling / sectional / counter doors, and associated components (e.g. hoods / shrouds, guides, curtains, slats, brackets, locking devices, gaskets, bottom bars, sensors, and seals).
31A - Doors, Frames & Hardware [FURNISH]	Scope of Work includes, but is not limited to: furnish and deliver all doors, frames, and hardware for the Stadium, Technology Building, Electrical Building, and all Gates. Subcontractor shall factory prepare products for hardware to be field installed. Work includes: frames, operators, cylinders, keying, hinges, pivots, power transfer devices, trim, bolts, push plates, pulls, locks (mechanical and electromechanical), latching devices, strikes, exit devices, closers, and other associated components / accessories. This Scope of Work excludes exterior storefront doors and hardware, including suite entrances from the exterior (bowl).
32A - Millwork – Suites	Scope of Work includes, but is not limited to: cabinets, wood paneling, fill panels, countertops, plastic laminate, shelving, moldings, running trim, door casements, hardware, etc. Locations include suites (bunker, lower, upper, and press), locker rooms, green rooms, and dressing rooms. Additional work includes: concierge desk(s), reception desk(s), banquettes, wood benches, and prefinished wood plank system. This Scope of Work excludes millwork at concessions and bars.
32B - Millwork - Concessions & Bars	Scope of Work includes, but is not limited to: curving millwork, bar counters, flip up counters, liquor cabinets, integrated lighting, cabinets, wood paneling, fill panels, countertops, plastic laminate, shelving, moldings, running trim, door casements, hardware, etc. Locations include suites (bunker, lower, upper, and press), locker rooms, green room. Additional work includes: mobile millwork and beverage stations. This Scope of Work excludes millwork at suites (bunker, lower, upper, and press), locker rooms, green rooms, and dressing rooms.
34A- Interior Stone & Tile - Suites & Locker Room	Scope of Work includes, but is not limited to: porcelain tile, glazed wall tile, floor underlayment, setting materials, grout, sealer, waterproof membrane (for work under this scope), crack isolation membrane, thresholds, and metal edge strips. Areas include the Suites and Locker Rooms (and adjoining spaces, e.g. hydrotherapy, steam, and dry sauna rooms). This Scope of Work excludes: BP #34b Interior Stone & Tile - Concessions & Bars, and BP #34c Interior Stone & Tile - Toilet Rooms.
34B - Interior Stone & Tile - Concessions & Bars	Scope of Work includes, but is not limited to: porcelain tile, glazed wall tile, floor underlayment, setting materials, grout, sealer, waterproof membrane (for work under this scope), crack isolation membrane, thresholds, and metal edge strips. Areas include concessions and bars. This Scope of Work excludes: BP #34a Interior Stone & Tile - Suites & Locker Room, and BP #34c Interior Stone & Tile - Toilet Rooms.
34C - Interior Stone & Tile - Toilet Rooms	Scope of Work includes, but is not limited to: porcelain tile, glazed wall tile, floor underlayment, setting materials, grout, sealer, waterproof membrane (for work under this scope), crack isolation membrane, thresholds, and metal edge strips. Areas include all toilet rooms. This Scope of Work excludes: BP #34a Interior Stone & Tile - Suites & Locker Room, and BP #34b Interior Stone & Tile - Concessions & Bars.
37A - Painting - Structural Steel	Scope of Work includes, but is not limited to: painting of all exposed structural steel scheduled to receive paint. Includes columns, beams, underside of deck, etc. Work includes touch-up of high performance coatings provided by Others. This Scope of Work excludes: intumescent paint and painting of interior areas.
37B - Painting - Field, Mezz., Main	Scope of Work includes, but is not limited to: block filler, concrete stain, primer, acrylic latex paint, and epoxy paint. Areas include the Field, Mezz., and Main (levels). Work includes paint at both interior and exterior locations. Work includes systems (e.g. mechanical, electrical, plumbing, and fire proofing) scheduled to receive paint. Additionally, this work includes all vinyl and textile wall-coverings. This Scope of Work excludes: intumescent paint, painting structural steel, and painting at the Suites, Club, Upper, and Press (levels).
37C - Painting - Suites, Club, Upper, Press	Scope of Work includes, but is not limited to: block filler, concrete stain, primer, acrylic latex paint, and epoxy paint. Areas include the Suites, Club, Upper, Press, and Catwalk (levels). Work includes paint at both interior and exterior locations. Work includes systems (e.g. mechanical, electrical, plumbing, and fire proofing) scheduled to receive paint. Additionally, this work includes all vinyl and textile wall-coverings. This Scope of Work excludes: intumescent paint, painting structural steel, and painting at the Field, Mezz., and Main (levels).
GC-29 Hoist	Scope of Work includes, but is not limited to: all engineering, installation, maintenance, and disassembly for two (2) external dual car hoists, totaling four (4) cars. Cars shall serve as material and personnel vertical transportation.
